USATT membership can be renewed/purchased at the event. Tournament Pass (\$10) is for one tournament only and cannot be upgraded to full membership.

Equipment: 10 STIGA and DHS Tables, DHS 40mm 3-Star Olympic Orange balls and barriers.

Entry Deadline: Entry must be postmarked by **May 26, 2008**. Entries postmarked late will be accepted with a \$5 late fee or will be rejected based on available space. If event is full, you will be placed in the next highest event. Check your status online.

Check-in: Starts at 7:30AM . Participants are required to check in 15 minutes prior to their **first** event.

Refunds: There will be **no** refunds after May 27, 2008.

Ratings: Ratings received from the USATT will be used. Players can check their USATT rating online at www.usatt.org

Policies: Tournament committee reserves the right to modify or cancel events and/or prize money if there are insufficient entries. Trophies (T) will be presented for runners-up when there are at least 4 players. Play will be conducted using USATT rules and regulations.

USATT dress code will be enforced. All decisions of the tournament director are final.

Tournament Format: All single events are round robin followed by single elimination.

Unrated players will **not** advance out of rated round robin events unless a rating can be reasonably assigned. Players who arrive 15 minutes after his/her event start time, will be defaulted without refunds. All matches are best 3 out of 5. Each session (8:00 AM and 10:30AM) will be limited to a maximum of **25** players).
